



# REPUBLIC OF SAN MARINO

**DECREE-LAW no. 64 of 5 April 2019**

**We the Captains Regent  
of the Most Serene Republic of San Marino**

*Having regard to the conditions of need and urgency referred to in Article 2, paragraph 2, letter b) of Constitutional Law no. 183 of 15 December 2005 and Article 12 of Qualified Law no. 184 of 15 December 2005, and more precisely:*

- *the need to facilitate the exercise of the right to vote for those citizens who permanently live in the rest home located in Fiorina and managed by the Complex Operational Unit “Residential Elderly Care” of the Social Security Institute and who, under Article 22 of Law no. 6 of 31 January 1996, as amended by Article 1 of Qualified Law no. 1 of 17 March 2016, would have to vote at the special polling station located at the State Hospital;*
- *the urgent need to promptly adopt a provision to establish an additional special polling station at the Complex Operational Unit “Residential Elderly Care” of the Social Security Institute, following the adoption of Regency Decrees no. 52 of 26 March 2019 and no. 56 of 28 March 2019, which establish admission to the propositive and confirmatory Referenda respectively to be held on 2 June 2019, in order to immediately prepare what is necessary for its application, considering the ordinary timing envisaged for the elections for the renewal of the Township Councils;*

*Having regard to Congress of State Decision no. 2, adopted during its sitting of 4 April 2019;*

*Having regard to Article 5, paragraph 2 of Constitutional Law no. 185/2005 and to Article 9, paragraph 1, and Article 10, paragraph 2 of Qualified Law no. 186/2005;*

*Promulgate and order the publication of the following Decree-Law:*

**AMENDMENTS TO ARTICLE 22 OF LAW NO. 6 OF 31 JANUARY 1996  
(ELECTORAL LAW) AND SUBSEQUENT AMENDMENTS - ESTABLISHMENT  
OF A SPECIAL POLLING STATION AT THE COMPLEX OPERATIONAL UNIT  
“RESIDENTIAL ELDERLY CARE” OF THE SOCIAL SECURITY INSTITUTE**

**Art. 1**

*(Amendments to Article 22 of Law no. 6/1996 and subsequent amendments)*

1. Article 22, paragraphs 3 and 4 of Law no. 6 of 31 January 1996 and subsequent amendments, as modified by Article 1 of Qualified Law no. 1 of 17 March 2016, shall be amended as follows:

“3. Voters hospitalised in the State Hospital shall be allowed to vote in the special polling station established therein; this special polling station shall be part of the first polling station of Borgo Maggiore, where all electoral operations following the termination of the voting operations shall take place.

4. Voters who permanently live at the Complex Operational Unit “Residential Elderly Care” of the Social Security Institute shall be allowed to vote in the special polling station established

therein; voters hosted in other public or private facilities, having concluded an agreement with the Social Security Institute, destined to permanently accommodate elderly people, shall also be allowed to vote in this station.

This special polling station shall belong to the first polling station of Domagnano, where all electoral operations following the termination of the voting operations shall take place.”.

**Art. 2**

*(Voting operations at special polling stations and home voting)*

1. The voting operations of the special polling stations, namely the State Hospital and the Complex Operational Unit “Residential Elderly Care” of the Social Security Institute, shall be carried out until 7.00 p.m., with the exception of the election operations for the renewal of the Heads of Township Council and of Township Councils, which, only with regard to the special polling station of the State Hospital, shall be carried out until 5.00 p.m. pursuant to Article 2 of Delegated Decree no. 53 of 23 April 2009.

2. The special polling station of the State Hospital shall remain competent for home voting as per Delegated Decree no. 117 of 13 December 2007 "Special polling station for non-transportable patients present in the territory" and subsequent amendments.
