



# REPUBBLICA DI SAN MARINO

**DELEGATED DECREE no. 128 of 30 July 2015**

**We the Captains Regent  
of the Most Serene Republic of San Marino**

*Having regard to Article 3, paragraph 5 of Law no. 125 of 29 July 2014;  
Having regard to Congress of State Decision no. 16 adopted during its sitting of 21 July 2015;  
Having regard to Article 5, paragraph 3 of Constitutional Law no. 185/2005 and to Articles 8 and 10, paragraph 2 of Qualified Law no. 186/2005;  
Promulgate and order the publication of the following Delegated Decree:*

## **INCOMPATIBILITY OF THE MEMBERS OF THE EXECUTIVE COMMITTEE OF THE CIVIL AVIATION AND MARITIME NAVIGATION AUTHORITY**

### **Art. 1** *(Definitions)*

1. For the purposes of this Delegated Decree, the following definitions shall apply:
  - a) Law: Law no. 125 of 29 July 2014;
  - b) Authority: the Civil Aviation and Maritime Navigation Authority of the Republic of San Marino

### **Art. 2** *(Incompatibilities)*

1. The office of member of the Executive Committee of the Authority shall not be held by:
  - a) directors and members of the executive body of companies, foundations or associations governed by private law subject to supervision by the Authority;
  - b) members of private-law companies subject to supervision by the Authority;
  - c) spouses and blood relatives and relatives by affinity up to the fourth degree of the persons referred to in a) and b);
  - d) other persons who have interest in conflict with the functions assigned by law to the Authority.
2. A person shall not be appointed as a member of the Executive Committee of the Authority referred to in Article 3 of Law no. 125 of 29 July 2014, if he/she:
  - a) is considered an “unfit person” pursuant to Article 1 of Law no. 47 of 23 February 2006 and subsequent amendments;
  - b) is subject to insolvency proceedings, whether in progress or concluded for less than five years;
  - c) has been subject, in his/her capacity as holder of flight crew licences, to disqualification or sanctions issued by a San Marino or foreign civil aviation control authority or body in the last five years.

3. The occurrence of a situation of incompatibility for a member of the Executive Committee shall result in his/her immediate removal from office. In such a case, the body responsible for the appointment of the member who has become incompatible shall replace him/her until the expiry of the Executive Committee's term of office.
